Fiscal Year 2017-2018 through Fiscal Year 2020-2021

Morris Community High School #101

Please complete the following schedule and include a brief description to identify any areas of the budget that will be impacted from one year to the next. If the deficit reduction plan relies upon new local revenues, identify contingencies for further budget reductions which will be enacted in the event those new revenues are not available.

1. Background and Narrative of Budget Reductions:

The district is developing a deficit reduction plan by analyzing the ability to use attrition when staff retire and making reductions where necessary. The district reduced educational fund salary and benefit expenditures by nearly \$500,000 over FY 16 levels. The district continues to look for ways to reduce costs with the least amount of impact on programs for students.

2. Assumptions Used in the Deficit Reduction Plan:

Our enrollment declined slightly during the economic downturn. I anticipate our use of working cash bonds to increase over the next three years as we attempt to sustain our level of service. In FY 12 we issued two years worth of Working Cash bonds to take advantage of low interest rates. The district will issue the same amount in Working Cash bonds as last year.

- Foundation Levels for General State Aid:

A slight increase in GSA will offset our loss of EAV in FY 17. An increase in the foundation level will be critical for our economic stability. Further reduction in GSA will have a negative impact on our level of service. The new EBFM will bring an additional \$250,000 to the district.

- Equal Assessed Valuation and Tax Rates:

Tax year 2013 EAV declined by 7%. EAV in 2014 declined by 2% and in 2015 by 1%. The EAV in 2017 grew by 4.25%. A tax rate of \$1.85-\$1.91 has been maintained throughout this downturn. It will become more difficult to contain the tax rate as our need to issue Working Cash bonds increase. Every attempt will be made to maintain or decrease our reliance on working cash bonds.

- Employee Salaries and Benefits:

The District is in year three of a three year collective bargaining agreement. Salary increases average 3% and health care costs remain constant.

- Short and Long Term Borrowing:**- Educational Impact:**

We have tried to minimize the impact on the classroom. If current trends continue, we may need to reduce additional staff. Several retirements over the past 2 years have helped contain costs. We will look to absorb as many of those positions as possible. In 2016, five staff members retired and by implementing our reduction plan, we saved approximately \$500,000.

- Other Assumptions:

We are using Working Cash bonds in an attempt to slowly build a cash balance and meet our operating needs. Our only long-term debt is from our 2003-2004 renovation project and has a fairly stable funding stream.

- Has the district considered shared services or outsourcing (Ex: Transportation, Insurance) If yes please explain:
Our district shares bussing with Elementary Dist #34 and has several business related intergovernmental agreements with all three elementary feeder districts. We have recently established a Shared Services Committee of the Superintendents and a Board member from each district. This group is exploring ways to increase efficiency. This year
